Introduction

Azul Zulu incorporates third-party licensed software packages. Some of these have distribution restrictions and some have only reporting requirements. This document lists the third-party licensed software packages for Azul Zulu products.

(Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it. Preamble

Although the Lesser General Public License is Less protective of the users' freedom, it does ensure that the user of a program that is linked with the Library has the freedom and the wherewithal to run that program using a modified version of the Library.

The precise terms and conditions for copying, distribution and modification follow. Pay close attention to the difference between a "work based on the library" and a "work that uses the library". TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

0.
