Introduction

Azul Zing incorporates third-party licensed software packages. Some of these have distribution restrictions and some have only reporting requirements. This document lists the third-party licensed software packages for Azul Zing products.

Preamble

The licenses for most software are designed to take away your

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. When we speak of free software, we are referring to freedom of use, not price. The precise terms and conditions for copying, distribution and modification follow. Pay close attention to the difference between a "work based on the library" and a "work that uses the library".
